You must have a check made out to DVWC for the exact amount of the difference between the two tests. Please note, due to possible travel restrictions, we may need to substitute judges accordingly.

## Entry Process and Directions

We are trying to avoid handling paper, money and checks, therefore are requesting all entries be submitted *via* email and payments be made *via* PayPal.

### PayPal Tips:

- To avoid paying a processing fee, make your payment from a bank account (savings/checking) associated with your PayPal account. If you pay with a credit card associated with your PayPal account, you will incur a 3% processing fee.
- If you do not have a PayPal account, you can pay with a credit card, but will be charged a 3% fee.

### Entry Process:

- Complete Entry Form and 2020 COVID-19 wavier and email both documents to Ratings secretary at [zephyrweim@aol.com](mailto:zephyrweim@aol.com) (entries close on Monday October 19, 2020 at 5:00 pm EST)
- To Pay, go to DVWC.org
  - Select 2020 Ratings *via* PayPal
  - Please check all tests for all dogs for all days and get one amount and pay that amount.
  - If you need to pull your entry, the DVWC will be able to send back your entry fees (minus a 3% service fee. This must be done prior to Closing Date.

- Your entry is not complete until the secretary has the Entry form, 2020 COVID-19 waiver and payment.

**Directions:** Colliers Mills, 299 E. Colliers Mill Road, New Egypt, NJ 08533

1. Take the New Jersey Turnpike to exit 7A.
2. After you pay the toll, take Route 195 east to exit 16A. (FYI: Assunpink was Exit 11)
3. At the exit ramp, make a right onto Route 537 West.
4. You will pass a Wawa and a McDonalds on your right (Last pit stop, Port-O-John time from now on). Continue on 537 past the entrance to Great Adventure on your right. After traveling on Route 537 for approximately 3.3 miles, you will see a sign for the Timberland Lake Campground on your right.
5. Just PAST this sign, make a left onto Hawkins Road. Please note that if you cross Route 539, you have gone too far.
6. Proceed approximately 2.8 miles to a stop sign.
7. Go straight at the stop sign for another 1.4 miles.
8. Make a left into the entrance to the Colliers Mills WMA.
9. Follow signs to ratings area – please drive slowly, dogs maybe running

## DELAWARE VALLEY WEIMARANER CLUB (DVWC)/GARDEN STATE WEIMARANER CLUB (GSWC) COVID-19 Ratings POLICY – October 24 and 25, 2020

The DVWC and GSWC look forward to seeing you and your gray dogs at our upcoming ratings on October 24-25, 2020 at Colliers Mills Wildlife Management Area. We will be implementing the following measures to help increase the safety of all participants and to ensure we do nothing to jeopardize our ability to hold future events at this site.

- Attendees should be limited to those who will be working their dogs and/or assisting with ratings. Additional observers should be kept to a minimum.
- Social distancing practices must be followed. If you do not live within the same household, you must remain 6 feet apart from one another while running your dog and/or watching others.
- Avoid congregating in groups or closer than 6 feet from one another. Park with sufficient space between vehicles.
- Face coverings should be worn when the 6 foot distance cannot be kept. All attendees should bring their own face covering.
- We will be providing hand sanitizers to use as you start running your dog and after your run has completed. Sanitizing wipes and/or spray will be used for all shared equipment. You are responsible for bringing your own sanitizer to use when you are not running your dog.
- No food or drinks will be provided by the clubs. You are responsible for bringing whatever food and drinks you will require for yourself and your dogs over the course of the ratings.
- If you have a pre-existing/underlying health condition or are at high risk for severe illness from COVID-19, please do not attend the ratings.
- If you are sick, feel sick or ill, or, if someone you live with or have been in close contact with is sick or ill, do not attend the ratings. If you become or feel ill during the ratings, you must leave immediately.

Your entry for the Ratings acknowledges that there will be an inherent risk in attending. By entering or attending, you are assuming that risk and agree not to hold DVWC and/or GSWC or its officers responsible. If you are not comfortable attending and feel you are at risk of contracting COVID-19, please do not attend. Ultimately, you are responsible for your own personal safety and health and the DVWC and/or GSWC will not be held accountable.
